## ENROLLMENT PACKET

*Registration is \$75 per student or \$200 for 3 or more thru 4/30/2026.*

*Starting 5/1/2026, registration is \$100 per student or \$250 for 3 or more.*

### INSTRUCTIONS FOR REGISTERING YOUR STUDENT(S)

1. Review the **2026-2027 School Year Costs** on page 2. Registration fees are due at the time of enrollment.
2. Applicant students must complete a placement test and lead teacher interview. New enrollment parents must attend an Interview Meeting with the principal prior to approval. Once approved, please complete and submit the **Admission Application** (Attachment 1) for each child that you wish to enroll for the school year.

**NOTE: Effective with the 2026-2027 school year, TVBS will be adopting a Continuous Enrollment policy. Continuous Enrollment simply means once your child is enrolled with Treasure Valley Baptist School, your child will remain enrolled until they graduate or until you notify us otherwise. In other words, you will never have to complete another annual re-enrollment agreement. Rather than an opt-in annual re-enrollment process, Continuous Enrollment is an opt-out process. Continuous enrollments must be approved by the principal each year.**

3. Complete and submit the **Medical Consent & Liability Release Form** (Attachment 2) for each child.
4. Sign and submit the **Parents' Agreement of Cooperation** (Attachment 3). Only one per family.
5. Complete and submit the **Family Financial Worksheet** (Attachment 4). Use this worksheet to compute your total costs and to indicate the tuition payment plan you want to follow for the 2026-2027 school year. Plans must be approved by the principal.

## CONTINUOUS ENROLLMENT FAQ

---

### WHAT IS CONTINUOUS ENROLLMENT?

*Continuous Enrollment simply means once your child is initially enrolled with Treasure Valley Baptist School, your child will remain enrolled until they graduate or until you notify us otherwise. In other words, you will never have to complete another annual re-enrollment agreement. Rather than an opt-in annual re-enrollment process, Continuous Enrollment is an opt-out process.*

### How do families opt-out?

*If your child is not returning to TVBS, you will need to opt-out by submitting an “Intent to Withdraw Form” by April 15<sup>th</sup>. (2027). The form can be found on the TVBS Web Site under the Resources page. <https://school.tvbc.org/resources/>*

### HOW DO FAMILIES FINANCIALLY COMMIT TO RETURNING EACH YEAR?

- *TVBS will continue to bill parents under the same Tuition Plan Agreement, unless you notify the school office in writing.*
  - *The annual re-enrollment fee will be billed in your account on May 1<sup>st</sup> of each year. If your child will not be returning for the 2027 academic year, you will need to opt out by submitting an "Intent to Withdraw Web Form" by April 15th to avoid paying the enrollment fee.*

### What about tuition and fee changes?

*Tuition rates will be published on our school website prior to the Intent to Withdrawal deadline.*

### What if families don't know if they are returning yet and need more time?

*If you need more time, you will need to Opt-Out and submit an “Intent to Withdraw Web Form” by April 15<sup>th</sup> to avoid paying the Re-enrollment Fee. You may re-enroll later, if there is space available.*

**Can the school choose to unenroll my child?**

***Yes, Treasure Valley Baptist School reserves the right to withdraw a student at any time due to student behavior or academic issues - or if families have delinquent financial obligations.***
